And, your education and training programs ensure everyday Victorians are armed with lifesaving skills in CPR, First Aid and Defibrillation.

The St John CPR Lab on display at the 2023 Government House Open Day, provided the opportunity for visitors to the House to learn the essentials of CPR. This year the lab has trained 9002 people with these lifesaving skills.

These are just some of the ways this Order has positively impacted the Victorian community.

They are significant achievements that would not have been possible without the altruism and generosity of St John members.
